PARADE PARTICIPATION AGREEMENT

This Parade Participation Agreement (hereinafter referred to as "Agreement") is made and entered into this ___ day of _____, 20___, but and between the City of New Berlin, a Wisconsin municipal corporation, through its 4th of July Commission (hereinafter referred to as the "City") and _____ (hereinafter referred to as "Unit Participant").

WHEREAS, the City operates a 4th of July Festival annually; and

WHEREAS, as part of the 4th of July Festival, the City also has a 4th of July parade (hereinafter the "20__ Parade"); and

WHEREAS, Unite Participant has experience in marching and providing parade performance in parade events; and

WHEREAS, the 20__ there of the City's 4th of July Festival is _____; and

WHEREAS, the parties are desirous of confirming the terms Of the Unit Participant's involvement in the 20__ Parade.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties do hereby covenant and agree as follows:

1. Unit Participant agrees to participate in the 20__ Parade.
2. In exchange for the Unit Participant's performance in the 20__ Parade, the Unit Participant shall receive the sum of \$ _____ at the conclusion of the event.
3. Unit Participant acknowledges receipt of the 20__ Main Parade Information Sheet, a copy of which is attached hereto and marked as Exhibit A, and agrees to follow the terms and conditions set forth therein.
4. The Unit Participant agrees to carry comprehensive general liability insurance with limits of not less than \$1,000,000.00 per occurrence and \$2,000,000.00 in the aggregate naming the City as an additional insured, and shall provide evidence of such insurance to the City of New Berlin not less than two weeks prior to the 20__ parade.
5. Unite Participant agrees to hold harmless the City, its officer, volunteers, agents and/or assigns as and all claims, demands, actions or causes of action that may arise against the City arising from the Unit Participant's performance in the 20__ parade. This hold harmless agreement shall include any claims arising from individual members of the Unit Participant's group.
6. This Agreement shall survive the completion of the performance of the services provided for hereunder.
7. This Agreement shall be governed and construed in accordance with the laws of the State of Wisconsin, and may only be amended by a subsequent agreement entered into by both parties.

8. This Agreement represents the complete understanding of the parties with respect to the subject matter set forth herein.
