Site Marker for Gov. Julius Heil's House, 19890 W. Julius Heil Dr.

Chairman Salzmann received a message from Fred Keller, chairman of the Waukesha County Historical Society Sites and Markers Committee, saying that he wanted to go over the Julius Heil Marker with her.

Linnie Lac Dam and Lake Site, formerly known as Hale's Mill Pond and Dam

Chairman Salzmann and former Comm. Zacher gave the finished City Landmark plaque for this site to Dorian Sullivan from the Linnie Lac Management District on September 23rd. LLMD will be having a Fund Raiser Dinner; the plaque will be presented at their meeting. LLMD will mount the plaque at the Dam. (A motion had been made, seconded, and carried at the 8/17/00 meeting to approve the amount of \$200 as the Landmark Commission's portion of the County's site marker, with the contingent that the Landmark Commission has the right to "proof" the copy.)

Designation of McWhorter House, 20635 W. Cleveland Ave.

Motion by Comm. Williams to designate the Meleski Landmark House as the Andrew McWhorter House on the plaque. Seconded by Ald. Chiovatero and carried unanimously.

Theodora Winton Youmans House (Viola Martin House), 19485 W. National Ave.

Comm. Hermann reported that the Historical Society had received \$100 from the Oconomowoc Women's Club and another \$10 from an (un-named) individual to help move the Theodora Winton Youmans House. Chairman Salzmann said that New Berlin resident, Catherine Gumieny, is donating \$1,000 for this project.

Grant Information

Comm. Williams gave the State Historical Society information on grants for "Bricks and Mortar" projects to Comm. Jashinsky. Comm. Jashinsky will send for grant applications. She said that she had talked to a member of the Youmans' family and we should try contacting other family members for donations. Comm. Hermann reported that the President of the New Berlin Historical Society had sent out letters to all local clubs to solicit donations.
