Linnie Lac Dam and Lake Site, formerly known as Hale's Mill Pond and Dam

The Andrew McWhorter House, 20635 W. Cleveland Ave.

Comm. Hermann brought in the finished plaque. Chairman Salzmann will deliver it to the current owners, Dave & Lynda Meleski.

Theodora Winton Youmans House (Viola Martin House), 19485 W. National Ave.

Motion by Chairman Salzmann to have the Landmarks Commission join with the New Berlin Historical Society in a book-signing program at the Library with Genevieve McBride, author of a book about Theodora Winton Youmans and her involvement in the Suffrage movement. Seconded by Ald. Chiovatero and carried unanimously.

The Historical Society will reserve the Library for sometime in June.

Comm. Hermann showed Commission members the flyer that she and Comm. Jashinsky had put together to help the Historical Society solicit funds from the community to further the moving project for this house. Comm. Hermann had also gotten a quote for printing the flyer, if approved.

Motion by Comm. Bowers to authorize the cost of \$140.00 to have 1,000 flyers printed. Seconded by Gene Wicihowski and carried unanimously.

Comm. Bowers said that she would check to see if the City and the Historical Society could split the cost of mailing the flyers.

Jashinsky will draft a letter for the Landmarks Commission (Comm. Hermann) and Historical Society (Don Hermann) to mail to those foundations.

Ken will continue to be welcomed at any meeting he may be able to attend.
