Attention Contractors

Effective May 13, 2020: The City of New Berlin has stopped sales of Recycling Center Contractor Load Permits.

All previously issued permits will be honored. The following requirements remain: All contractors must be a New Berlin business. All yard waste must be from New Berlin properties. They will be required to sign a form and show proof that their business is located in New Berlin and that the yard waste they are dumping is from New Berlin properties only. Contractors are required to see the attendant prior to unloading to have their cards punched for each load.

RESIDENTIAL USE ONLY. Proof of residency required. Businesses must contract with a hauler for recyclables.

ACCEPTED ITEMS

ANTI-FREEZE- USED: 3 Gallons maximum per visit

APPLIANCES: stoves, ovens, ranges, refrigerators, washers, dryers, dishwashers, microwaves, water heaters, air conditioners, furnace, boilers, dehumidifiers, freezers, water coolers,

MISC: exercise equipment; grills (without propane tank), lawn mowers and snow blowers (fluids drained)

CAR BATTERIES

YARD WASTE: Branches (less than 12" diameter, no stumps), leaves, grass clippings, garden plants

CANS: Aluminum, Steel, Tin

CARDBOARD: Must be flattened and bundled and must be under 4 feet by 3 feet

DIRT or SOD: 1 Cubic yard maximum per visit

GLASS: Bottles and jars only (No broken glass accepted)

PAPER: Junk mail, newspapers, magazines, printer paper, telephone books and paperback books

MOTOR OIL: USED

PLASTIC BOTTLES: Coded 1, 2, 4, 5, 7 **ONLY**

SCRAP METAL: motors must be drained of fluids

ITEMS NOT ACCEPTED

COMPUTERS, TELEVISIONS AND ELECTRONICS: We are NOT accepting electronics at the Recycling Center.

Tires are not accepted but can usually be disposed of at tire dealerships for a charge.

NO styrofoam, concrete, cooking oils, landscape ties, household batteries, propane tanks, carpeting, mattresses, furniture, lumber, windows, mirrors, construction debris, broken glass, ashes, rocks, sand, roots, stumps, bricks.

NO HAZARDOUS MATERIALS: Such as Paints, Cleaners, Gasoline, Driveway sealer, etc.

Truck/Trailers Must be rated at ¾ ton or less.
