Ford #2 Copperhorn: AY McDonald 40-N2 Copperhorn

Neptune Meter: 5/8" x 3/4" T-10 (1" Spud x 7½" Spread)

FOR 3/4" METER

Ford #2 Copperhorn: AY McDonald 40-N2 Copperhorn

Neptune Meter: 3/4" SL T-10 (1" Spud x 7½" Spread)

FOR 1" METER

Ford 34 Copperhorn: 40-N4 Copperhorn

Neptune Meter: 1" T-10 (1¼" Spud x 11" Spread)

Water meter will not be provided without the listed meter horn installed.

Plumber shall be charged a re-inspection fee if the meter horn installation is incorrect.
